Annual Meeting Frequently Asked Questions

- 1. Do I have to attend?** While attendance is not mandatory, we encourage you as a member-owner to participate. The directors elected to serve on the cooperative's board of directors represent the interests of the members and are responsible for setting major policies and working with the cooperative's management to develop policies and plans for the cooperative.
- 2. Can I vote by proxy?** Yes, fill out the proxy card on the back of the annual meeting guide you will receive in September and bring it into the office or give it to another member that is going to attend.
- 3. I am married. Do we get one vote or two?** A married couple is allowed only one vote even if they have more than one service.
- 4. I am married and only my name appears on the membership. If I can't attend, can my spouse cast our vote?** No, only the name that appears on the membership can vote. Call the business office if you want to change the names(s) that appear on the membership.
- 5. I own a business and a home, how many votes do I get?** Only one vote per person. If your business is a corporation, then you will have 2 votes.
- 6. Do I need an active account to vote?** Yes, you must have an active membership to vote.
- 7. A group of us own a hunting cabin and the account is not in my name. Can I vote?** No, the membership has to be in your name.

More Alternatives To Cutting Cable TV

If you pay for **Amazon Prime**, you already have access to one of the best alternatives to cable available: Amazon Prime Video. But, even if you don't need Prime shipping, you can also pay for the service on its own for about \$9 per month. Like other streaming giants, you gain access to a giant library of content and original programming. As a bonus, if something you want isn't on Prime but is available through Amazon, you may have the ability to rent it, including single television episodes.

Sling TV operates more like actual cable or satellite television, making it a great option for those looking to cut the cord. The basic package, available for about \$20, includes 30 live channels, including popular ones like HGTV, ESPN, and Disney. There are also several other line-ups and add-ons that give you the ability to customize your service a bit. Sling TV is probably the closest thing to à la carte television service available, so it's worth exploring.

It wasn't long ago that the only way to watch programming from HBO, Showtime, and Starz was through add-on subscriptions on a cable package. Now, these premium channels have their own online streaming services, usually for between \$9 and \$15 a month.
